My name Patrick Lee, and I am the Treasurer of the Christian Legal Society ("CLS"). My email is ptlee@law.gwu.edu and my number is (714) 793-7543. The CLS President, Christian Lake, can be reached at clake@law.gwu.edu. We respectfully ask that the SBA finance committee grant CLS' ad hoc request of \$240.20 dollars for the CLS Speaker Panel in early February. We ask that you grant this amount for the following reasons.

The event includes three panel speakers who will be from a major law firm in D.C., a judicial clerk at the Federal District Court for the District of Columbia, and a former GW Law graduate who is currently practicing law in the House Budget Committee. The event will be moderated by our president Christian Lake and is aimed to inform students of the various legal practices and to answer any questions students may have in regards to pragmatic steps to find employment. Particularly, we hope to provide 1Ls with an opportunity to learn about the various paths that are available to them in the field of law. We ask that you cover the cost of food that will be provided at the meeting for the attendees. We believe that the Panel will attract more students than are usually at the meeting. Please see attachment B, for the itemized breakdown of the cost.

Further, we are estimating that we will need roughly \$9 per attendee/food item and plan to cater from somewhere like Chipotle. We are expecting roughly 25 attendees. Thus, $(25*9)+\text{Tax}$ would roughly be \$240.20.

For all these above-mentioned reasons, we ask that you approve our requested funds. Attached to this letter are exhibits which further itemize our requested costs.
